DIVESTURE ORDER

Having read the application of the trustee pursuant to paragraph 2.7 of the order of the Competition Tribunal issued on 27 August 2012 and having heard counsel for the parties, the Competition Tribunal orders as follows:

 Subject to the provisions of this order and any terms agreed between the First Respondent and P Le Grange & Sons ("PLG"), the First Respondent shall dispose to PLG who shall acquire the assets listed in Annexure A of this order ("Offer Assets").

- 2. The consideration payable for the Offer Assets shall be the sum of the amounts for each specified category of the Offer Assets as reflected in Tables 1 to 5 of Annexure A of this order, and which shall be payable in cash or by other means acceptable to the First Respondent, and on collection of the Offer Assets or within 10 (ten) days of this order, whichever is the earlier.
- 3. The Offer Assets shall be disposed of with no warranties or representations, and furthermore shall be disposed of on a "voetstoots" basis.
- 4. PLG shall collect the Offer Assets from the premises of the First Respondent within 10 (ten) business days of this order or any further period agreed between PLG and the First Respondent.
- 5. PLG shall not dispose or otherwise relinquish all or part control of the asset listed in **Table 1** of **Annexure A** for a period of at least 3 (three) years from date of this order. PLG shall not dispose or otherwise relinquish all or part control of the assets listed in **Tables 2 to 5** of **Annexure A** for a period of at least 1 (one) year from date of this order.
- 6. Should PLG or its shareholders intend to enter into a transaction to dispose of all or part control of the business of PLG within 3 (three) years of the date of this order, PLG shall inform the Competition Commission and the First Respondent in writing of this intention. The Competition Commission shall as soon as reasonably possible thereafter make a determination in terms of section 13(2) of the Competition Act, 1998.
- 7. Should PLG elect not to acquire any of the Offer Assets, PLG shall notify the First Respondent of its election within 5 (five) business days of this order and

the Trustee shall dispose of these assets pursuant to clause 8 of this order. The Trustee may authorise or mandate the First Respondent to dispose of any of the Offer Assets.

The Trustee/First Respondent shall, within 1 (one) month of the date of this 8. order or as soon as reasonably possible thereafter, dispose of the assets listed in Annexure B of this order ("Non-Offer Assets") to the highest bidder by public auction. No firm that is partially or wholly controlled, whether directly or indirectly, by Naspers Limited may bid at such public auction.

The Trustee/ First Respondent shall notify the Competition Commission in 9. writing once the last of the disposals pursuant to this order are completed, which shall include suitable proof of all disposals pursuant to this order.

10. The costs of the application pursuant to paragraph 2.7 of the order of the Competition Tribunal issued on 27 August 2012 shall be borne by each party.
